NOTICE OF RACE

1. Rules:

The Regatta is organized under the authority of The Charlotte Harbor Yacht Club (CHYC). This regatta will be governed by the US Sailing The Racing Rules of Sailing (RRS) 2009 – 2012 and by the “Class Rules” of the WFPHRF.

2. Eligibility:

The regatta is open to boats having a current WFPHRF rating Spin, Non spin, Cruiser, Multi hull and other one design boats. A 4 race only CHYC-issued provisional rating will be allowed in lieu of a WFPHRF certificate for first-time racers. This is an interim rating only for boats intending to obtain a WFPHRF rating. Contact Series Chairmen for ratings by 09:00 hrs. prior to the event.

3. Entry and Fees:

A completed Wednesday Night Series entry form must be received by CHYC office no later than 16:00 hrs of the day event. No entry fees are required. **This is really for fun.**

**Note: All competitors are welcome to attend an after race social in the Wheel Room CHYC. Mooring along the center dock will be first come first served.
Cash Bar and food will be available.**

5. Racing Area

The racing area will be in Peace River west of the US 41 South Bridge and East of Marker “2”. Starting area is at 3A.

6. Sailing Instructions

Sailing Instructions will be available at CHYC on May 23, 2009 or contact Series Chairmen.

7. Protests & Penalties

Protest are not encouraged (This really is to be for fun) but if a protest is required see the Sailing Instruction. RRS 44.1 will be in effect.

8. Scoring

A recorded list of finishing position and time of day to finish will be post at the Wheel Room after each night of racing.
